3. Public Policy update

a. Information Literacy Bill A 4169. Approved in Assembly. DOE weighing in. NJASL finds amendments acceptable. Seems that Governor will sign it.

4. Executive Board update

a. NJLA Construction Fund task force. Advocating for funding in state budget annually to update libraries. Construction Bond cycle just ended. HOpe to continually set aside funds for libraries. Also trying to equitably cover the whole state with representatives for the process from North NJ, South NJ, and Central NJ.
