- State Library
 - NJSL + Partners Literacy Grant Project
 - The New Jersey State Library (NJSL), through an American Rescue Plan Act of 2021 (ARPA) grant from the Institute of Museum and Library Services (IMLS), created the NJSL + Partners Literacy Grant Project to establish public libraries as local literacy hubs that support residents in achieving literacy – digital, financial, workforce, adult basic, English

language – according to local need(s). Two pilot projects have been developed:

- **Project 1 <Hub and Spoke Libraries>** will use a Hub and Spoke model for developing formal literacy programs at public libraries using model established by and in alignment with Plainfield Public Library.
- **Project 2 <Access Navigators Program>** managed by NJLA will use a Navigator model that brings trained staff to libraries to work with residents in need of literacy services.
- The call for grant applications for the Hub and Spoke Libraries has now been closed. The awardee libraries will be announced after Labor day. The Access Navigator Program is searching for the Program Coordinator and 5 navigators positions at this time.

- Next Possible Steps: create a survey for libraries to add input to go fine-free
- Ashley: smaller libraries have issues with fines because they have less funding
 - Start with the benefits that help the community

- Don't assume people can't return items because they don't have addresses
- Brianna: webinar led by YOLO county librarian Mark Fink about Fine Free.

- Sharon: We provide temp card for patrons without addresses in Newark
 - Need numbers for how many things are returned, etc.
- Oct.-Nov.: send both surveys possible date
- Spectrum Scholarship: idea to send out 300 flyers to all libraries for them to know
 - Send to school counselors for students
 - Use library mail campaigns, social medias to share info
- Selwa: create a PSA video of librarians and workers of color for them to share experiences
 - Most people of color don't know that to be a librarian is to have a MLIS!
