Working on Literacy Boot Camp for all types of libraries.

- Registration will open the last week of July. 25-30 participants, the session is free.
- A series of meetings from Sept Dec., 9:00 am to 3:30 pm, one per month.
- Topics covered: ESL, Adult Education, GED, some grant opportunities and how to approach those grants.
- Meeting place: Plainfield Public Library. They developed a workbook that will be used.
- NJ Association of Lifelong Learning will be involved
- Showcasing best practices Bringing in representatives from libraries to give examples.
- Hands-on learning
- This is the first time this is being done. It is not just for librarians.
- This is separate from the Dept. of Labor grant announced at NJLA conference.

The Labor Dept. has not been in communication with the State Library since April, so there are no new developments on the grant.

Mental Health First Aid training for youth services librarians. Focus is for ages 12-18. All the spots are taken, so there is a wait list. There will be another training in Monroe Twp., October 15 & 22, registration has not opened yet.
