State Legislation

Per Capita State Aid – (A3267) (S3587 – last year's bill#) Top Priority
FY 2023 Budget Request is \$10,600,000. In FY 2022 NJ Libraries received \$4,629,240, a 56% shortfall in funding.

 - Allows public libraries to dispose of certain materials without advertising for bids.

Additional Priorities that PPC Supports

Library Network Aid (no new bill number)

Provides funding for shared resources through deliveries across the state's libraries. This funding also supports the technologies that power library statewide resource sharing. In addition, funding from this appropriation is dedicated to the State Library Resource Center in Trenton. We are requesting an increase in the FY23 appropriation, to restore this funding bill to where it was, prior to the cuts made to the bill in 2010.

Digital Equity Grant

\$25 million, from the State of New Jersey's ARPA funds, to equip New Jersey's libraries as conduits for building a digitally inclusive New Jersey. There are more than 400 public library buildings in New Jersey, accessible to all New Jersey residents.

To provide true digital equity, we must make sure that all residents of New Jersey (no matter their age), have access to the technology, connectivity and training that is imperative today for basic life's needs. With funding, New Jersey's libraries stand ready to expand our efforts in bridging widening inequities in broadband access, connectivity, digital literacy, and access to technology devices.

Strategies for Broadband Funding (A850)

We are enthused that a NJ library representative is included in the Broadband Access Study Commission. We assert that NJ's libraries are best equipped to implement the Community Broadband model. The State of New Jersey can build upon existing infrastructure in libraries, without reinventing the wheel. This is the most efficient, effective, and cost savings strategy for achieving Broadband Access for all New Jersey residents.

Libraries are community anchors, and we serve as conduits to the actualization of individual and community hopes and aspirations. We are there 24/7, through digital and physical resources, helping New Jersey residents to improve the quality of their lives. New Jersey's libraries are imperative to building a vibrant and thriving New Jersey, with equitable access to life resources for all our residents.

The Digital Equity and Broadband subcommittee continues to explore opportunities for funding.

A Permanent Library Construction Fund Bill

Based on the surveys conducted for the New Jersey Construction Bond Act and new post-Covid facility safety expectations, it is clear that there is a critical need for funding to repair, renovate, and expand public library infrastructure. The establishment of an annual budgeted fund would provide the necessary capital to provide for a healthy and robust library environment in New Jersey.

The Permanent Library Construction subcommittee is currently researching and developing a plan.
