3. Start to Develop a NJLA Financial Policy

- a. At Juliet's recommendation, the group will look to create a Financial Policy for NJLA with the minimum goals of:
 - i. Protect the assets of the New Jersey Library Association
 - ii. Ensure the maintenance of accurate records of NJLA's financial activities
 - iii. Provide a framework for NJLA's financial decision making, including an established budget threshold ("never to spend below" amount, six months to a year of operational costs)
 - iv. Establish financial operating standards and behavioral expectations
 - v. Serve as a training resource for staff; and
 - vi. Ensure compliance with federal, state and local legal reporting requirements.
 - vii. A group, including Eileen, James, Karen C, Phillip, Samantha and Juliet will develop a draft financial policy using a template (M.A.I.N) and incorporate information from existing NJLA policies and the document prepared by Pat Tumulty.
 - viii. Then the policy should also be reviewed by the auditors, the NJLA Board Budget Committee and finally the NJLA Executive board.
 - ix. The policy should be reviewed regularly by the Finance Committee
