The NJLA archives are now housed at the Talking Book and Braille Center, Ewing Township, NJ. Members of the H&P Section had asked about them, and H&P leadership contacted NJLA leadership to discuss their access and organization. On February 23, 2021, interested parties of the H&P Section met to discuss suggestions for improving the organization and maintenance of the archives. Conclusion: The assessments and recommendations laid out in a 1996 CAPES report are still valid today. Ken will contact the NJLA Executive Board and report that H&P members agreed that the organization should implement the first three recommendations listed in the CAPES survey.
