- Success stories Partnerships and Collaborations with School Media Specialists
 - o <u>librarianmo@gmail.com</u> email Mo Donohue with success stories.
 - Attended NJASAL program about this topic, and now librarian as sole teen services, is juggling all media specialists interest.
 - Bribe with free books at middle school. Lunch Munch special pass to have munchkins given to students. Get to see kids who do not come to public library. Monthly visit. Miss Jenna. 10 per lunch period.
 - Research project for third graders. Make sure get library card. Waived rules to have parents ID. All kids who signed up got called out of class and got library card. A scanning of library card to make it official. Pictures taken. A lot were after school but didn't have card until now.
 - School media specialist got rid of reading list, made point based program where they receive points for doing different things at the library. Three things. ATtend library program (each program a point), listen to an audiobook, get a library card. 150% of teen participation and attendance. Almost 50 kids for movie attendance. Captain Marvel and Jaws.
 - Issue library cards to each school, library cards are not given to teacher, librarian holds, no fine account. Increased teachers willingness to use public library's resources. Not every teacher great about giving back. (East Brunswick). Some books do not returned.
 - New media specialist, also a patron, and immediately the school media specialist, asked to have a summer reading talk, and through word of mouth, others school media specialists heard. Ended up going to two schools out of three that were

interested. Huge number of kids signing up for summer reading. Numbers were up, but evened out. Good to see all kids excited.

- Non-success story: May be getting book mobile to school media specialist, sounds scary and horrible said media specialist. East Brunswick
- Mo Donohue, representative of the NJLA/NJASL Joint Task Force
 - Fear of losing school media specialists if public librarians can do that. School libraries are being turned into maker spaces. Allen McGinley said goes to bookstores with coffee shops makes searching more enjoyable but went to book bookstore but got rid of books, he'd say why here? He's here for books, not really coffee. Same thing with maker spaces in libraries, enhances space but gets rid of librarian, doesn't really enhance. First library children encounter is school media specialist. Not all parents bring their children to libraries.
 - Two pieces of legislation.
 - Information Literacy Curriculum to show why school media specialists are necessary.
 - Student to school media specialist ratio
 - Got school media specialists on state report card, but each report card is late and ration is not mathematically correct.

 May be 1 librarian going to 7 schools.
 - Once a job is lost, nothing we can do. Look into budget before jobs get cut.
 - Commercial NJASL: 30 minute spot. NJASL has rights to all footage.

 - Check list: check on your school librarian for administrators
 - To public librarians: you are only there to support school media specialists not do their job.
 - Elevator pitch will be on website.
 - Joe Falensa (spelling): collecting data, going into schools up to Freshman year of college.
 - Trying to save the position, not specifically the person (however, doesn't want to lose jobs)
 - Study going on if lost job or librarian certificates given out or those hired who are school media employees that are not librarians; state education department doesn't have that.

 - Circulation changes: New cataloging system, audiobook customized to specific individual. All books on one cartridge, disposable, return. Erase and reload.
