Possible topics: how unions benefit library workers, including directors; how to form a union; how negotiation takes place and how it takes "forever" to get a contract ratified; how a local union representing library workers might be aligned, and as examples of types of unions: AAUP-AFT (college/university faculty), CWA (Communications Workers of America), retail industry.
 - b. Speakers -- would like to have three to four panelists, five at the most:
 - Allison Ryan, Adult Services Supervisor at the Montgomery Branch at Somerset County Library System of New Jersey, represented by OPEIU (Office and Professional Employees International Union) Local 32.
 - ii. Beth Zak-Cohen, Librarian, Charles F. Cummings New Jersey Information Center at the Newark Public Library. President of AFSCME, Local 2298, Council 63.
 - iii. Amy Joyner, Treasurer Secretary of AFSCME COLT Local 1761, Council63, representing library workers at Rutgers University.
 - iv. Moderator: Eric.
- 4. Annual salary guide
 - a. <u>Salary guide</u> approved by executive board on Nov. 21. After the meeting, Eric made one requested change (moving disclaimer to page 1 from page 2), and making multiple minor changes. Eric sent a copy to the subcommittee, and the NJLA office (Brett Bonfield and Katy White).
 - b. Publication and promotion of the guide. Published in Dec. 8 NewsAlert.
 - c. Verification on whether salary offers that libraries publish in their job ads on the NJLA job hotline actually do meet the salary guide minimums when libraries say that they do.

 - a. Salaries
 - i. Whether a library meets or uses the NJLA salary recommendations.
 - ii. Databases and/or other previously untapped statistics.
 - b. Union membership: Which libraries have unions and whom they represent.
 - c. Civil Service membership. The NJ Civil Service Commission maintains a list of Civil Service agencies by municipality. There are 72 libraries on the list as of Nov. 22, 2023, separated out in this spreadsheet. Eric added this list to the NJLA Members website on Dec. 12.
 - d. The NJLA's Library Workers of Color Section (LWOC) held virtual sessions, co-sponsored by LWOC and by LibraryLink NJ (LLNJ) in May 2022 on Civil Service and on unions. The Civil Service program was held Thursday, May 12, 2022, at 2 p.m. The union program was held Thursday, May 19, 2022, at 2 p.m. "Human resource consultants Melissa Czaplicki and Zeslyn Wade from the New Jersey Civil Service Commission will present on a variety of topics specific to job titles, promotions, trainings, and more. The program on unions will give attendees a stronger idea of what unions do, why they are important, and how they can get involved. All NJ library workers are welcome to attend." Yolanda said that about 80 people attended each of the two sessions and that the contact person is Keisha Miller.
